Annual Health Examinations and Consultations

Vaccinations are injections cats and dogs are given to protect them against common and dangerous infectious diseases like parvovirus. Puppies should be vaccinated at 6, 8, 12 and 16 weeks of age and kittens at 8, 12 and 16 weeks. Adult cats and dogs need an annual vaccination to remain protected. A booster vaccination then needs to be given a year after the last puppy/ kitten vaccination.

Deworming

Worms are common parasites that your dog may carry, often without showing signs. They can cause serious diseases in pets and also in people. It is important to ensure adult dogs and cats are dewormed every 3 months. Puppies should be dewormed once a month, from 2 to 6 months of age.

Flea and Tick Treatment

Fleas and ticks are common parasites that can cause a wide variety of problems like skin allergies and life-threatening diseases like tick bite fever. They can transmit diseases to humans as well. We recommend year-round protection for your pet against these parasites and offer a wide variety of effective flea and tick control products.

Annual Dental Exam and Regular Teeth Cleaning

Dental disease is the most common disease in pets over 3 years of age. Untreated, it leads to pain, tooth loss and potentially life-threatening infection of major organs.

Besides brushing your pet's teeth regularly, it is important to go for annual health check-ups, as your vet will be able to spot any problems and can assess your pet's dental health.

Sterilisation of Males and Females

Microchipping is a permanent identification device method, where a small chip is inserted under the skin between the shoulders. It is not a tracking device but can prevent your pet from getting lost forever. It is often required for documentation like export permits, pedigree forms and pet insurance.
